Hello family,

I was just looking for a format to write this report and came across a similar report from last June excitedly reporting our getting the bid for AVCNA 40 in 2023. Well, this report will be a duplicate of last years without all the excitement of last year as the VRCC Board is always full of surprises.

Yes, we were awarded the bid for AVCNA 40, January 6-8 and again at the Marriott Resort 4100 Atlantic Ave on the site of the Old Cavalier Beach Club. The contract has been sweetened a little bit, but the basic sticking point of meeting space fees has not changed. The Chair and Vice chair will be visiting the property and hammering out a contract to bring back to our next meeting during our retreat in Winchester, VA July 16-18.
