10. Discretionary budget to cap at \$250.00 at which point excess funds to be distributed 75% to SOTS and 25% to Region. Intent: N/A \*Amendment to above October 2021 - Motion made by Budget Sub-committee & seconded by Fresh Start: Any funds donated back to the Area from SOTS shall be excluded from the formula and shall be distributed at the body's discretion at the ASC meeting the following month. Intent: To ensure funds are distributed efficiently.
