#### **Web Servant Report:**

The domain registrations for <u>virginiabeachna.org</u> and <u>virginiabeachna.com</u> are both renewing on 6/4/2023. Geoff took care of adding the Area's payment information onto the GoDaddy account. Thank you Geoff! The Cloudaccess webhosting account is paid through 03/30/2024.

Of note, I checked on the status of the domain name <a href="beachareana.org">beachareana.org</a> and noticed it is now forwarding to <a href="tidewaterareana.org">tidewaterareana.org</a>. As I recall, it was previously forwarding to a different location. I cannot find any information on who owns the domain, and we have no way to control how it is forwarded or redirected.

Information in the Webservant passdown file is up-to-date. A copy of that file is being provided to the Secretary for safekeeping in case of need.

We have current backups, up-to-date software, meeting information, event information, and phone line volunteer scheduling. The meeting list PDFs are formatted properly legible. With that said, there is so much more that needs to be done to attract the newcomer and carry the message on the technical platforms.

Phone volunteers are up-to-date. We currently have 4 females, 2 males, and 1 non-binary volunteer(s). We had 4 calls in May lasting between 4-9 minutes each.
