There is a lot in this report, so please be patient with me. Through researching previous BANA minutes between the years of 2020 and 2022, it appears that the BANA body has tasked ENC to create a PR/PI policy and have the committee sit in a 1-year incubation period under ENC providing PR services. Per the minutes, this 1-year incubation period and policy has been fulfilled over the 2 years mentioned. In 2022, Sam B. stepped down and nobody filled the position. Long story short, there is already a Public Relations/Public Information subcommittee with corresponding policy manual that has been formed in previous years but because nobody stepped into the position after Sam, it fell under the radar in BANA. Today, the subcommittee is nominating Shawn B. who is qualified to fulfill the position of PR/PI Chair. The body will need to confirm this nomination during new business with elections. Once confirmed, the subcommittee will be its own separate entity and has an established budget of \$200 per its policy.
