Over the last month, the Vice Chair, Vice Treasurer, and I, were able to open a bank account for BANA. It is called a Community Partner account at Towne Bank that is registered under Beach Area Service Committee NA. This will allow us to add and remove signers as needed. The Vice Treasurer and I have created online accounts with Towne Bank and are waiting for an email from the bank with our login information and directions. BANA money from the previous account is currently in the process of being transferred over. It will take a few days because the other account only allows a certain amount of money to be transferred via Zelle per day. One thing to note is that Lance G. sent checks from the previous account to the PO Box we currently have, which we cannot access, and they are stuck in that box. He declined reimbursement for the checks. The Treasurer will go over all of this in their report. Because of the new bank account, the motion from last month for ENC to create a description for a trusted servant to open an account is void.

BANA and ENC policies have been updated and should be uploaded to the website. I have printed physical copies of each to be used for reference during area service for GSRs. Please do not take these home. Lastly, now that we have a bank account, I will get a PO Box hopefully before next area. At this time, the address for the bank account is registered to my home address. As soon as we get the PO Box, I will be changing the address. If you have any questions, please feel free to ask.

Exciting news! We got a bank account!!! We are now banking with Towne Bank. The funds are being transferred to our account within the next couple days because of limits within the bank to transfer. We cannot get money directly sent to our business account. The money got sent to Whitney and she has a check written for 1000 from her account that I will deposit Monday. The remaining balance due to us is 1651.73. This will also be transferred to Whitney and I will deposit. By midweek all of the transfers will be complete and our account will fully be ours and functioning. We do not have checks for the old account still so we cannot write a check from the ABNB account to the Towne Bank account. The checks that a member of the body ordered got sent to the PO Box that we do not have access too. Which is why we as an executive team made the decision to go with the transfers. We have screen shots to show the transfers being done honorably. If anyone would like to see those please let us know. We have done our best as an executive team to be transparent in this process and are available for any questions.

Some information about the account: this is a community partner account set up with our EIN and falls under the Business sphere. There is no debit card and we have six checks currently and our wonderful Vice Treasurer ordering more checks. Per policy we have three check signers, and it is simple to change as the executive board changes. The signers are the chair, vice chair, and the vice treasurer.

We will be getting the new PO Box set up before next area since we now have the ability to use the bank account with ease. I will also have a suggested region donation within the next month or so. I know that has been a large concern for the body and I am grateful that I will be able to start back with regular donations.

Our wonderful executive board really stepped up and helped me out with getting this bank account set up. I had surgery this month and was not as involved in the process as I wanted to be.I want to say that I am so grateful to them in figuring this out. This has been a year long process and I am appreciative for them. I am so blessed to be able to serve with this body and team.

We will have our first budget review for the year next month. It will be held here at 1200 Damn Neck Rd before area at 11am here in the kitchen. The date for that will be March 1st. GSR's PLEASE pass this info along to your HGs. If anyone has questions about budget or where they want the 7th tradition money going to this is where you want to be.
